Committee Name:

Committee of the Whole

Committee Make-up:

The Committee shall be made up of the Mayor and all

members of Council.

Reporting Nature:

Except for assignments specifically directed for action by lawful delegation of Council, the Committee of the Whole shall report its findings and recommendations to Council for its debate, approval and action.

Rules of Procedure:

The Committee of the Whole shall follow the Council Procedure Bylaw as amended from time to time, in the conduct

of its business.

Meetings shall be open to the public except for those topics that fall within Section 90 of the Community Charter,

"Meetings that may or must be closed to the public."

The Chair of the meeting shall rotate amongst Mayor and Council, with Council Chairs in accordance with the schedule

of Deputy Mayors for that year.

Committee of the Whole meetings shall be scheduled for the

second and fourth Mondays of each month at 4:30 p.m.

Staff Liaison:

A staff liaison(s) shall attend all Committee of the Whole meetings for the purpose of recording the minutes of meetings

of the Committee, and providing administrative support.

Other Resources:

The Committee may engage the services of those professionals required to fulfill the purpose of the Committee. The

Committee may also engage other resource persons for its

purposes, under approved budgets.

Committee Purpose:

The Committee purpose shall be to consider general topics of

discussion referred by Council and the introduction of new

legislation and/or policy.
